YOUTH SOCCER ACADEMY: WITH HAITIAN GOVERNMENT COVID MANDATES RESTRICTING PROGRAMS IN THE SPRING AND SUMMER OF 2020, THE PLH SOCCER PROGRAM HAD TO TAKE AN UNEXPECTED BREAK. PRACTICES RESTARTED LATE SUMMER, AND IN NOVEMBER, WE LAUNCHED THE PLH SOCCER ACADEMY. THIS NEW STRUCTURE ALLOWED FOR MORE DISCIPLESHIP, MORE FOCUSED ATTENTION AND TRAINING, AND HAND-PICKED, CONTRACTED COACHES. THE YOUTH OF HAITI HAVE FEW OPTIONS FOR SAFE PLAY AND FEW OPPORTUNITIES TO GROW AND LEARN WITHIN POSITIVE ENVIRONMENTS. AT THE SAME TIME, THEY FACE MANY TEMPTATIONS TO TURN TO UNHEALTHY OR CRIMINAL LIFESTYLES. THE PLH SOCCER PROGRAM AND ACADEMY PROVIDES KIDS WITH A SAFE PLACE TO PLAY, A COACHING STAFF THAT CARES ABOUT THEM, AND AN OPPORTUNITY TO GROW IN BOTH THEIR SPORT AND THEIR LIFE. CONTINUED IN SCHEDULE O.

THE INSTITUTE EMPLOYS TWO HAITIAN INSTRUCTORS.
